Ice chests are not allowed in the main auditorium at any time. They may be placed in the meeting room, kitchen and/or concession area and placed against the wall.

FLOORS: When setting up, DO NOT DRAG tables, chairs, ice chest, decorations, etc.

Extensive scratching of the floors may constitute damage for which the vendor would be responsible.

NO TAPE/TAPING, COLORING OR GLUING ON THE FLOORS. Extremely heavy equipment must be approved prior to entering the building.

Absolutely NO VEHICLES OF ANY TYPE ARE ALLOWED INSIDE THE BUILDING.

EXCEPTION: MOTORIZED WHEELCHAIRS. WALLS: Absolutely NOTHING on the walls: NO TAPING, GLUING, TACKING, OR COLORING OF ANY TYPE ON WALLS, CEILING OR STAGE.

TABLE COVERING: All tables are preferred to have table cloth or coverings to look presentable.

OPEN FLAMES: Absolutely NO open flames, flame producing devices, or any inflammable or combustible materials will be allowed inside of the Wm. H. Scott Civic center, this includes but is not limited to the following: torches, incense burners, and floating candles. If using floating candles, flames are not to be exposed. Pan warmers may be used if pre-approved by the Center Manager. Pan warmer guidelines will be provided at contract signing and must be followed.

DRINKS: ABSOLUTELY NO GLASS CONTAINERS.

ENTRIES: No marked FIRE EXITS are to be obstructed by stationary items (chairs, tables, etc.).

This is a State Fire Code Requirement

No food or drinks allowed from outside of the event

No alcohol

No smoking on or near facility

No foul language, disruptive, belittling and/or threatening behavior on property/grounds

No weapons

No drugs

Please be kind to others, facility and grounds of Wm. H. Scott Civic Center. Please help keep restrooms, facilities and grounds clean after use.

Peli Con, The City of New Roads, and Wm. H. Scott Civic Center WILL NOT be responsible for injuries, broken items, misplaced or stolen items, property damages caused by vendors, guests and/or attendees.
